Why do I want to attend a seminar?

Conditions of participation:

The prerequisite for participation in the seminar is sending the completed application form by the participant to the address and within the time specified in the invitation.

No later than 21 days before the date of the seminar, the Organizer will send participants via e-mail a confirmation of participation in the seminar, including details of the organization of the seminar and details of the date and amount of the fee for participation in the seminar, as well as the number of the account to which the fee should be paid.

The participant is obliged to pay the fee for participation in the project on time, in accordance with the information provided in the confirmation of participation. The organizer reserves the right to cancel the seminar or change its date 14 days before the date of its holding.

In the event of resignation from participation within 14 days before the start of the seminar (the date of receipt of the declaration of resignation by the Organizer is decisive), the participant is entitled to a refund of the fee paid, after deducting operating costs of 3% of the fee.

If the resignation is received later than 14 days before the start of the seminar or the participant does not show up for the seminar, the participant bears the full cost of participation. If he finds another person to take his place, he will not be charged.

Resignation from participation in the project should be sent to the Organizer by e-mail to the e-mail address of the seminar coordinator.

The Participant agrees to the Organizer recording his or her image by photographing and filming the seminar. The Participant agrees to the subsequent free use of the above-mentioned materials to promote the seminar in any way chosen by the Organizer. The Participant agrees that the copyrights to the texts, photographs, audio and video materials created as part of the project with his or her participation will be transferred to the Organizer(s) of the project. We inform you that:

1. Personal data is processed in order to carry out the recruitment process and registration of participation in the seminar.
2. Personal data will be stored for the period necessary to settle the seminar, but no longer than until March 31, 2025.
3. After the processing of personal data for the original purpose is completed, the data will be deleted.
4. Providing personal data is voluntary, but necessary to participate in the seminar.
5. Personal data may be transferred to other entities in order to settle any funds received for the implementation of the program. The Foundation provides personal data to processors and third parties to the extent necessary for the proper organization of its business. The above means that access to data may also be granted to entities providing services supporting the process of promotion, sale or provision of services by the Foundation, including using automatic tools. Each time, however, the sharing takes place only within the framework of the Foundation's rights, as well as on the basis of appropriate legal safeguards (contracts).
6. As a data administrator, we provide you with the right to access data, rectify them, request their removal or limit their processing. You can also exercise the right to object to the Administrator against data processing and the right to transfer data to another data administrator. In the case of voluntary consent, you have the right to withdraw your consent to the processing of data at any time, which does not affect the lawfulness of the processing that was made on the basis of consent before its withdrawal. We also inform you that you have the right to lodge a complaint with the body supervising compliance with the provisions on the protection of personal data.
